
This year can be summarized in a few words: In the face of significant challenges, we made significant progress.

# Featured Unit of the Quarter Marine/Agriculture Unit

The Marine and Agriculture unit is uniquely combined creating a cost effective and efficient public service; aligning with Sheriff Leeper's commitment to community service.



The detectives assigned to the unit were selected for their expertise, job knowledge, skills and abilities, as well as professionalism. The assignment calls for a level of dedication placing personal life in second.

Detective Clements served thirteen years in the United States Navy and has spent the last fourteen years committed to Nassau County, working an array of assignments beginning in patrol moving to CID and ending up in the Marine/Agriculture Unit where he also serves as a certified scuba diver.

Detective Booth has spent the last eighteen years serving Nassau County beginning his career as a correction officer moving to the courthouse and on to patrol. He also served in CID, Internal Affairs, and currently in the Marine/Agriculture Unit.

Both Detective Clements and Detective

Booth are certified instructors as well as firearms instructors enabling them to assist when the need arises for training and firearms qualifications.

Jacksonville Sheriff's Office. Recently, they have assisted with escorts for Navy submarines into Kings Bay and patrolled the waterways when the President of the United States visited.

With thousands of acres in the county, the need for the Agricultural Unit occurs often. They continually look for stolen vehicles,

illegal dumping, trespassing and suspicious

activity on the land owners property which requires four wheel drive equipment.

Additional, the

Agriculture Unit assists special events with parades, the fair, the car show as well as school career days.

Statically the unit had been involved in the following:

♦ 51 special events.

- ♦ 837 Vehicle/Vessel stops. (257 were boating safety checks)
- 56 arrests

The equipment assigned to the unit, of which they maintain, consists of the following:

#### NASSAU/DUVAL SHERIFFS ANNOUNCE ALLIANCE TO "CATCH THE BAD GUYS"



"If a criminal lives in Duval County, but robs a store in Nassau, we want our deputies to know they can work that case along with the JSO for the benefit of both communities," Sheriff Leeper and his staff were joined by Duval Sheriff John Rutherford along with members of the JSO's Zone 6 patrol and enforcement team, during the announcement held at the Dunn Avenue police sub-station.

The north side of Jacksonville/ Duval County shares a border with Nassau County, and includes highly travelled roadways such as US 1, I-95, US-17 and Heckscher Drive. Nassau County also borders Georgia to the north. The *Cops Without Borders* cooperative policing agreement already exists between Clay County and Duval.

The Cops Without Borders policing program stemmed from the creation of the Southeast Law Enforcement Alliance Project (LinX), a shared law enforcement database created with funding from NCIS and used by agencies throughout the region to share information about crime and criminal activity.

Clay County Sheriff Rick Beseler and Duval County Sheriff John Rutherford launched *Cops Without Borders* between Clay and Duval in 2007, so that Clay deputies and JSO officers could expand their partnership. Commanders routinely sit down and discuss cases where suspects are living in one jurisdiction and committing crimes in the adjoining county, for example.

One example of the agreement is in the event of a pursuit, when the suspect crosses the county line. Officers can follow the suspects into the adjoining county, quickly notify the local authority, get assistance if needed, and then make the arrest in the other jurisdiction. They can return suspects for questioning that have been located in the next county, as well.



"I am very pleased that we could take this proven concept of policing for the good of the entire area and expanded it to our law enforcement partners in Nassau County," said Sheriff John Rutherford.

"The bad guys don't have geographic boundaries. They don't stop at the county line and rethink their actions...so *Cops Without Borders* is a powerful way to implement the many policing tools and intelligence, and use it cooperatively, with colleagues in neighboring counties," Rutherford said.

"I like the idea that no matter where you live – if you commit crime in the area – we can investigate and share that intelligence easily and ultimately, we can come get you," said Sheriff Leeper. This program is similar with the partnership recently developed between NCSO and Fernandina Beach Police Department.

Officers are meeting regularly to share information and tactics to get the guns, drugs and the criminals who use them. "For the lawbreakers, the message is when you cross the line, so will law enforcement in Nassau or Duval counties" Leeper added.

# Nassau Deputies capture notorious 'cat burglar'...

Nassau Sheriff's Deputies captured one of the nation's most notorious cat burglar in Hilliard, Florida after being notified by Tennessee, Georgia and South Carolina police authorities he might be in the area.

"Blane David Nordahl, 51, from Jacksonville, was arrested on two warrants out of Atlanta, Georgia after he showed up at the Canterberry Apartments in Hilliard to meet his girlfriend's daughter.

After a short foot pursuit, he was arrested and booked into the Nassau County Detention Facility with no bond. The Warrants were for "Burglary with Intent to Commit a First Degree Felony" and "Conspiracy to Commit a Felony" Sheriff Bill Leeper said.

Blane David Nordahl, known as "The Silver Thief" and "Burglar to the Stars", made his living pilfering expensive silver items, from fancy homes across the East Coast of America. He is believed to have netted \$3 million in around 150 burglaries throughout his criminal career.

Despite his professional approach to burglary, he has been caught numerous times and served an eight year sentence after being convicted of stealing \$50,000 worth of silver cutlery from the home of Ivana Trump.

Other notables he stole from were Sportscaster Curt Gowdy and Musician/Singer Bruce Springsteen.

In a burglary typical of his modus operandi, he would approach a target house at night while the owners were asleep and carefully remove panes of glass from a French door, thus avoiding any alarms that may be triggered by picking the lock. He would even sometimes sneak past sleeping dogs. When all alarms were disabled, he would remove entire drawers full of silver items and take them outside to test them with his own silver test kit; plate silver would be thrown away at the scene and he would leave with only the finest and most expensive items.

Nordahl would steal an average of around \$20,000 worth of silver in a single burglary.

"Nordahl mainly stole silver because it is usually kept in the kitchen and dining areas, which made it easier to take and not disturb anyone in the home" said Leeper.

# Advancements in equipment...What's New?

#### **In-car Cameras**

We are currently conducting trials with three in-car camera manufacturers seeking to upgrade the outdated system currently being used.

Thus far, there has been very positive feedback regarding a particular systems video quality, automatic upload, and expandability to a body camera. We will continue to evaluate the systems, rendering a decision in the very near future.

#### **Vehicle Replacement**

With the start of the new budged year you probably have noticed the new patrol vehicles on the road.



The life end of the current vehicles has been at or over the 200,000 mile range. We have found, through a cost benefit analysis, that the up keep and maintenance becomes cost prohibitive. We will be purchasing the Caprice & Tahoe Police Patrol Vehicles (PPV).

The price difference between the Caprice and Tahoe is minimal, not to mention the gas mileage variance is within two to three miles per gallon.

An immediate advantage is the ability to put a Tahoe in an area where off-road conditions prevail.

You will notice the new appearance that Sheriff Leeper approved adds to the cost



savings by not having to paint each vehicle. The reflective striping enhances safety not only to each deputy, but also for every passing vehicle alike.

#### **Building Security**

Surely you have noticed the new security measures that have recently been implemented!

What started out as an upgrade in the facility security for accreditation purposes has a long lasting effect; portability!

Lets start with the controlled access for vehicular traffic. Installing the gate

closer has created a deterrent to unauthorized vehicles.

The addition of the camera and card reader system allows for activity in and around the facility to be observed and captured. More importantly, the system is designed with the future administrative building in mind.



With the exception of the hard wire each mechanism can be relocated to the new facility when the time comes. Strict care was taken to not over install devices and while obtaining necessary security so that there is minimal cost associated with the re-install.



This exemplifies the goal of operating the NCSO in the most efficient and effective manner that the citizens expect.

#### Crime Fighting Advancements...Facial Recognition Program

The Nassau County Sheriff's Office has obtained a facial recognition system with the assistance from the Pinellas County Sheriff's Office through a \$3.5 million grant that the Pinellas County Sheriff's Office received from the U.S. Department of Defense.

Facial recognition is one of the most powerful new technologies being used by law enforcement. By using facial recognition on a pre-booking image, deputies have the ability to compare the suspect's face against the 5,000,000 images already in the database and match the image to the correct identity should the suspect provide false information.

On a typical day the Sheriff's Office will deal with individuals such as: a man arrested for disorderly conduct; an inmate awaiting release from the detention facility; a thief who has used the identities of his victims to gain access to their finances; and the screening of wanted criminals, etc.

By using the facial recognition program, deputies can conduct a face recognition search wire-lessly to determine if the individual has been previously arrested. As a result, deputies can immediately determine if an individual being questioned has a prior criminal record and/or is wanted in order to make a necessary arrest on the spot.

The NSCO has found the face recognition program to be an invaluable tool in providing quick

and accurate identity information on individuals, allowing officers to correctly identify even the most uncooperative suspects and conduct more efficient investigations.

#### **Marijuana Grow House Bust!**

On October 14, 2013, Nassau County Sheriff's Office Narcotics Deputies busted a marijuana grow operation off Haddock Road in Hilliard, Florida. Deputies seized 80 plants, with an estimated street




value of \$80,000. The sophisticated grow operation was planted and maintained by Jerry Lewis Ganey, 59, of Hilliard, who was arrested for Possession of more than 20 grams of Marijuana with Intent to Distribute and Cultivating Marijuana.

#### **Fingerprint Identification**

Patrol deputies arrested two persons in a domestic situation. The female was attempting to hide from the deputies and when questioned gave a name and dob that could not be found in any of the common data-

# Citizens Academy...

Sheriff Leeper has announced a new Citizens Law Enforcement Academy (CLEA), an educational, informational and informative program which allows citizens the opportunity to learn about the issues that face law enforcement in Nassau County.

The ultimate goal of a CLEA is to educate the community, build a partnership and reduce crime; the concept is an extension of the goal of Community Policing.

#### The general objectives of our Civilian Law Enforcement Academy (CLEA) are to:

- Dispel misconceptions of how the Sheriff's Office operates by explaining our procedures and why the agency functions the way it does.
- Create "community ambassadors" who will take information from the CLEA and spread positive information to their neighbors.

The Nassau County Sheriff's Office will host a Citizens Law Enforcement Academy class semiannually. The program is informational only and does not train or promote citizens to act in a law enforcement capacity.

Classes will include a tour of NCSO's facilities, patrol operations, traffic enforcement, hostage negotiations, vice and narcotics, crime scene investigations, corrections, and 911 communications dispatch. Students will also watch a K-9 demonstration and visit the firearms range to take part in weapon safety training

The CLEA graduate will glean the knowledge desired to become a volunteer for the Nassau County Sheriff's Office.

To be eligible to attend the Civilian Law Enforcement Academy (CLEA) you must:

- Reside in or be employed in Nassau County.
- Be at least 18 years of age.
- Have no felony convictions and no misdemeanor convictions in the last 3 years.
- Possess a valid driver's license or other form of government ID.
- Complete an application.

# Accreditation Update ...

As you know we have been diligently working on receiving our first re-accreditation designation with the Commission for Florida Law Enforcement Accreditation (CFA). October 9-11th we had a team of three assessors come in and perform a "Mock" inspection. three assessors, Agent Tim Elder with FDLE, Major Amy Schmidt with FWC and Officer James Joiner with UNF Police Department reviewed our polices and made suggestions for improvement. They were very impressed with everyone on staff.

After following the Mock team's suggestions and advice, on December 4-6th three assessors with the CFA arrived to conduct our "Onsite" (formal) inspection.

The Assessors, Chief

Michelle Morris with Sebastian Police Department, Lieutenant James Fannin with Walton County Sheriffs Office and Accreditation Coordinator, Cynthia Pugsley with Orange County Sheriffs Office spent three days carefully reviewing our policies and practices. The assessors were very complimentary of our staffs working knowledge and professionalism. They were also pleased with the efforts that all members have contributed to improving and moving our agency forward. They are presently working on their final reports for the Commissions review.

While we will not officially know our status until the week of February 3rd, when the Commission hearings and voting will take place, we are anticipating that we will receive our reaccreditation sta-

fus.

Thank you to each and every one of you for your hard work and dedication over these last few months in preparation for these accreditation inspections. Without everyone's assistance we could not reach this goal together.

At the start of the New Year we will begin going through inspections again; only this time it will be for our 2nd re-accreditation at the jail. The Florida Corrections Accreditation Commission (FCAC) will send assessors to come in for three days to review our policies and procedures at our Detention Center. At this time we are anticipating that we will be holding a mock inspection the first part of February and the official "Onsite" around the end of March. As we get closer to setting up those dates we will update you.

# **Home Security Tips**

Since daytime burglaries are becoming more prevalent, we'd like to offer a few tips to help you protect your most valuable asset, your family:

Have a plan of action should a burglar enter your home. Prepare a hiding place and an escape route. It is especially important to practice with the children—just like you would "in case of a fire."

For the room that is designated as the hiding place, have a wedge ready to put under the door. This makes it even more difficult for a burglar to get through the door.

Teach children the proper use of calling 911. Many kids have been able to save the life of a family member by knowing how to call.

Install daylight sensor lighting

so your property is always lit up at night. Partial lighting that goes full force with motion sensors is OK too.

Put your driver's license number on EVERY item of value you would miss if taken— laptops, TVs, computers and firearms, etc. This makes them more difficult to pawn and easier to find you if they are retrieved. You can also photograph items to show proof of ownership.

Shut and lock your home and garage doors whether you are home or not. Burglars have slipped in and out of homes in a flash to take items off counters or from the garage.

REMEMBER, your life is more valuable than your property, PLEASE be safe!
