(In alphabetical order. The Nassau County Sheriff's Office ("NCSO") does not endorse or recommend any particular Special Process Server. Each of the following Special Process Servers have been approved and certified by NCSO.)

Effective January 1, 2023, the Nassau County Sheriff's Office will no longer serve non-enforceable service of process, as defined by Florida law, through Deputy Sheriffs. Instead, all non-enforceable service of process will be exclusively performed by Special Process Servers approved and certified by NCSO, pursuant to section 48.021, Florida Statutes.
